

The initial management of all work-related injuries and exposures, including counseling, risk assessment, and treatment, should begin at the training site where the incident occurred.

- All work-related injuries, needlesticks, or exposures must be immediately communicated to the individuals listed below:
  - Program Director
  - Program Coordinator
  - OHS Fresno
- For initial care, visit the Employee/Occupational Health Services where the incident occurred during office hours (please call the appropriate number below to confirm hours) or at the Emergency Department after hours.
- Complete the [Employee Incident Report](#) and email it to OHS at [Fresno-OHS@ucsf.edu](mailto:Fresno-OHS@ucsf.edu) for processing and further instructions.
- For needlestick and exposure incidents, report the incident to OHS Fresno at 559-499-6630 during office hours (Monday to Friday, 7:00 AM - 3:30 PM).
  - During after-hours and weekends, contact the UCSF Health Needlestick Hotline at 415-353-7842 or the backline at 415-353-4008 and follow up with OHS Fresno on the next business day.
